Dear Alec:

Below are the rational and the calculations for quantity of the Whisper Walls 1" Square Edge Stretching System components used in Whisper Walls Stretched-Fabric Wall System, that would be used in the standard school classroom and the standard private office defined in CDPH Standard Method V1.2.

CLASSROOM

While it is typical that only one or two walls may be covered in the Whisper Walls Stretched-Fabric Wall System, the worst case in a Classroom of 40' x 24' x 8.5' would be that all four walls would be covered. If four walls had Whisper Walls on the 1088 SF of wall surface, there would be approximately 631 lineal feet of the Whisper Walls 1" Square Edge Stretching System installed.

OFFICE

While it is typical that only one or two walls may be covered in the Whisper Walls Stretched-Fabric Wall System, the worst case in an Office of 12' x 10' x 9' would be that all four walls would be covered. If four walls had Whisper Walls on the 414 SF of wall surface, there would be approximately 240 lineal feet of the Whisper Walls 1" Square Edge Stretching System installed.
